**COURSE:**

**Human Trafficking and Investigations**  
**Hosted by Indiana HIDTA**

**DESCRIPTION:**

This course covers eight-hours of first-hand experiences and findings within organizations engaged in human trafficking. The class consists of classroom lecture and practical classroom exercises. We will cover how organized crime is directly related to Human Trafficking as well as other criminal activities. Human trafficking, smuggling, and modern day slavery are in the United States and prospering with very little resistance. These activities are no longer in other countries; it's here in our backyard. Organized criminal groups are using the same smuggling routes to gain access to the United States and also using the same type of concealment as narcotics smugglers. At the end of this course, students will learn from start to finish how to successfully identify, investigate, infiltrate and convict these organizations. Students will be able to conduct interviews; understand the different organized crime groups; know the required documentation; understand safety issues involved and be able to write a written report and be able to present a court case.
